TOWN BOARD MEETING – SHELburn COMMUNITY BUILDING  
October 18, 2022

The meeting was called to order by President Jesse Kasinger at 6:00pm with members Brad Cagle, John Curtis, and Jesse Kasinger all in attendance in person with member Alex Norris joining in virtually on the TV.

Clerk Treasurer Melissa Copeland read the minutes of the meeting held on September 13, 2022 and all minutes were approved by the Town Council.

Council President Kasinger made a motion to adopt the proposed ordinance 2022-09-13, an ordinance of the town council of Shelburn, Sullivan County, Indiana Establishing an Ordinance regarding disclosure of public records, for a second time as well as vote to bypass the third vote since it was unanimous. Seconded by Council Member Brad Cagle, All in favor.

Council President Kasinger made a motion to withdrawal from the EDA Water Project Grant due to rising costs and being unable to fill the financial gap. Seconded by Council Member Alex Norris, All in favor.






At 7:21pm a motion was made by President Kasinger to adjourn the meeting, seconded by Brad Cagle, all in favor.

Alex Norris


