

TOWN BOARD MEETING – SHELburn COMMUNITY BUILDING  
June 13, 2023

The meeting was called to order by Council President Jesse Kasinger at 6:00pm with members Brad Cagle, John Curtis, Alex Norris, and Council President Jesse Kasinger, all in attendance.

Clerk Treasurer Melissa Copeland read the minutes of the meeting held on May 9, 2023, all minutes were approved by the Town Council.

An opportunity was given to allow any community members in attendance to speak on behalf of the town, possibly considering a Town Wide Trash Service. After public comments were addressed, Council Member Brad Cagle made a motion that the Town of Shelburn move forward with creating an ordinance for Town Wide Trash Pick Up, seconded by Council Member Alex Norris. All in Favor.

Council President Jesse Kasinger made a motion to stop using Doug Starkey dba D&D Property Solutions as the 2023 Mowing Contractor due to the Council not being happy with the quality of work and hire Bryan Thrasher to replace him for the remaining 2023 Mowing Season, seconded by Brad Cagle. All in Favor.

Council Member Brad Cagle made a motion to amend the current ordinance of 90.04 Livestock Prohibited Within Town limits to exclude ducks from the ordinance, seconded by Council Member Alex Norris. All in Favor.

Council Member Alex Norris made a motion to adopt a new ordinance Chapter 90, Section 04 to titled "Shelburn Backyard Chicken and Fowl Ordinance" to allow residents within the town limits to own Chickens and/or Waterfowl, seconded by John Curtis. All in Favor.

Council President Jesse Kasinger made a motion to accept the Fuel Policy for the new Casey's Fuel Mastercards for all employees and reserves who use the card, seconded by Alex Norris. All in Favor.


Council Member Alex Norris made a motion for Clerk Treasurer Melissa Copeland to transfer \$150 from the Promotional Fund to the Park Board Recreational Fund as a donation for the Back to School Event, seconded by Brad Cagle. All in Favor.


Due to the passing of Park Board President Kenny Miller, there is now an opening on the Shelburn Park Board that has two years left of its term. Council President Jesse Kasinger made a motion to have Clerk Treasurer Melissa Copeland makes a post announcing the vacancy, seconded by Council Member Alex Norris. All in Favor.


A motion to approve the claim voucher was made by Council Member Alex Norris, with a second by Council Member Brad Cagle. All in Favor.

At 7:13pm a motion was made by Council President Jesse Kasinger to adjourn the meeting, seconded by Brad Cagle. All in favor.
