

TOWN OF SHELburn

TOWN BOARD MEETING – SHELburn COMMUNITY BUILDING  
July 11, 2023

The meeting was called to order by Council Member Brad Cagle at 6:00pm with members Brad Cagle, John Curtis, and Alex Norris in attendance. Council President Jesse Kasinger was not in attendance.

Clerk Treasurer Melissa Copeland read the minutes of the meeting held on June 13, 2023, all minutes were approved by the Town Council.

At the June 13, 2023 Council Meeting, the Town Council voted to adopt a new ordinance titled "Shelburn Backyard Chicken and Fowl Ordinance" however, the Council forgot to sign the ordinance. Clerk Treasurer Melissa Copeland requested that they vote to adopt the ordinance again and then to sign the ordinance since they forgot last time. A motion was made by Council Member Brad Cagle to adopt the new ordinance Chapter 90, Section 04 titled "Shelburn Backyard Chicken and Fowl Ordinance" to allow residents within the town limits to own Chickens and/or Waterfowl, seconded by Alex Norris. All in Favor.

Council Member Alex Norris made a motion to appoint Heather Lewis on the Shelburn Park Board, she will take Kenny Miller's place and her term will expire at the end of 2024. Seconded by John Curtis. All in Favor.

Council Member Alex Norris made a motion to adopt "Resolution of the Town of Shelburn, Sullivan County, Indiana, Authorizing Property Acquisition from the Northeast School Corporation, Sullivan County, Indiana," seconded by Council Member John Curtis. All in Favor.

Council Member Brad Cagle made a motion to request EDA's consideration of Termination for Cause for the EDA 06-79-06329 Shelburn Water Project, seconded by Alex Norris. All in Favor.

Council Member Alex Norris made a motion to adopt Resolution No. 2023-07-11-1 the "Resolution Authorizing an Expenditure from the American Rescue Plan Funds Under the Town of Shelburn Standard Allowance" to allow the purchase of RAFA System Monitoring and remote control of the Waterworks System from BBC Pump and Equipment Company, Inc. and the amount to not exceed \$50,000, seconded by Council Member John Curtis. All in Favor.


